AAI GIS CIRCULAR 2 OF 2019

Subject: Authorization to AAI Empanelled Survey Firms for issuance of Site Coordinates & Site Elevation Certificate for issuance of NOC for height clearance by AAI

Airports Authority of India, after following the due process, has empanelled 7 Survey Firms for conducting the Aeronautical Survey of the airports managed by AAI. The list of Empanelled Survey Firms was circulated vide GIS Circular 01/2019 dated 12.06.2019 (copy enclosed as Annexure-I).

The AAI Empanelled Survey Firms listed in the AAI GIS Circular 01/2019 are hereby authorised to issue the Site Coordinates & Site Elevation Certificate, as per AAI, Department of Aerodrome Safeguarding Format available on NOCAS website > Link: [http://nocas2.aai.aero/nocas/AAI Links/Format of Site Elevation and Coordinates Certificate.pdf](http://nocas2.aai.aero/nocas/AAI%20Links/Format%20of%20Site%20Elevation%20and%20Coordinates%20Certificate.pdf), to the applicants who wish to apply to AAI for NOC for height clearance as per the provisions of GSR-751(E) or any other Notification issued by Ministry of Civil Aviation, Govt. of India for the purpose, as per the following terms & conditions:

1. The AAI Empanelled Survey Firms shall not charge more than the rates quoted in the Table give below:

Plot Size	Max. Cost excluding GST
500 sq. m or less	Rs.10,000/- (up to 4 coordinates with elevation) Rs. 2,000/- for each additional points
501 sq. m to 4000 sq. m	Rs.15,000/- (up to 6 coordinates with elevation) Rs. 3,000/- for each additional points
4001 sq. m to 10000 sq. m	Rs.25,000/- (up to 8 coordinates with elevation) Rs. 4,000/- for each additional points
Above 10000 sq. m	Rs.50,000/- (up to 10 coordinates with elevation) Rs. 5,000/- for each additional points
Travel Cost	Travel cost may be added by the Survey Agency if they are not located in the city based on number of surveyors required.

2. The Empanelled Survey Firms shall fulfil the following conditions:
 - a) The actual survey of the site has to be carried out by the trained Surveyor-cum-GIS Analyst by using the survey grade equipment such as Electronic Total Station and Differential GPS as per GIS Circular 01 of 2018.

- b) The site survey and issuance of coordinates certificate should be completed at the earliest but not later than 30 days from the request made by the applicant. A copy of the survey & coordinates certificate shall also be sent to the concerned Airport Director.
 - c) A list of the sites for which survey certificates have been provided in a month, along with the amount charged, shall be submitted to the concerned Airport Director and to the General Manager (DoAS), AAI CHQ, New Delhi by 10th day of next month.
 - d) The authorised Survey Firm and the Airport Operator shall suitably publish the AAI mandated fee structure, both on online and offline.
3. Authorization, as indicated in AAI GIS Circular 01 of 2019, is subject to the compliance of the conditions by the Empanelled Survey Firms and may be cancelled in case of non-compliance/default.
 4. Airport Operators of the licensed airports may also provide the site coordinates/elevation certificate for the NOC applicants as per the above fee structure.
 5. This Circular will be effective from 1st August 2019.


