# Minutes of the Meeting of the Appellate Committee held on 27<sup>th</sup> December, 2013

Reference Ministry of Civil Aviation letter No. AV.20036/66/2000-AAI dated 15-10-2012 read with letters dated 31-12-2012 and dated 04-01-2013, the Appellate Committee constituted to consider appeal/grievance made by different applicants with regard to the height allocated to them by AAI for their construction vis-à-vis the height sought by them, held its meeting under the Chairmanship of Joint Secretary, Ministry of Civil Aviation (MOCA) on 27<sup>th</sup> December, 2013.

The Committee was assisted by Shri V.K. Dutta, ED (ATM) and Sh. A.K. Bhardwaj, GM (ATM-NOC) of Airports Authority of India (AAI).

The Committee decided that review of NOCs issued by Regional / Station level NOC Cells in those cases which do not penetrate AGA surfaces should be dealt by AAI and need not be brought to the Appellate Committee.

The following decisions were taken for the Appeal cases that were brought up in this Committee Meeting:

The proposed site lies in outer horizontal surface and is 11918.9 m from ARP of Safdarjung Airport. The applicant had initially requested a height of 508 m AMSL vide their letter dated 28.08.2011 against which they were granted a height of 460 m AMSL vide letter dated 07.10.2011 The applicant thereafter in his letter dated 01.11.2012 requested a revised height of 508 m AMSL.

The case was heard in the Appellate Committee Meeting of 9<sup>th</sup> January, 2013. In this meeting, the applicant was informed that the case was re-examined in AAI and the permissible height of building Spira Tower available to them may be 487 m AMSL with certain conditions. The applicant agreed to the height of 487 m AMSL applicable to them.

The case was again heard in the AC meeting on 27<sup>th</sup> November, 2013 and the Committee decided that the calculations for permissible height as calculated by CNS may be placed before the Committee in next meeting for final decision.

This meeting considered the calculations submitted by AAI on the CNS criteria which indicated that as per the coordinates supplied by the applicant, the Spira Tower alone is permitted to a height of 487 m AMSL as it is a small object with respect to RADAR signals. The other buildings in the plot are restricted to height of 459.77 m AMSL.

<u>Committees' Decision</u>: The applicant to be granted a height of 487 m AMSL for Spira Tower and the other buildings in that plot to be granted a height of 459.77 m AMSL. While granting the NOC, the coordinates of the corners of the buildings to be specified. The NOC should be issued with the note that this NOC is for specific single structure at particular locations only and shall not be utilized at other location, even in the same plot.

The proposed site lies in IHS and is 2868 m from Rwy 14 end of Santa Cruz Airport. The applicant had earlier requested for 69.975 m AMSL on 22.12.2008 against which they were granted 56.27 m AMSL vide AAI letter dated 01.10.2009. The applicant had requested for revised height of 93.67 m AMSL in his letter of 16.04.2012.

During the presentation in the AC meeting of 11<sup>th</sup> October, 2013, the applicant stated that his project involves setting up Multi-Super-Specialty Hospital and revised FSI norms had been granted by the local authorities and that additional height has been sought to consume full FSI.

The applicant was asked to clarify the revised norms and the FSI granted and whether the project is supported by the local state government authorities. The applicant was asked in the meeting of 11<sup>th</sup> October, 2013 to submit documents within 15 days from the concerned local state authorities clarifying the revised norms and FSI granted and also justification in support of the project for the height sought by the applicant.



The applicant submitted the required documents vide their letter dated 22<sup>nd</sup> October, 2013 which was examined by the Committee. Though the letter from the state local body has supported the project but had not justified the requirement of height as sought by the applicant. The applicant had also requested for Aeronautical Study.

<u>Committees' Decision</u>: An Aeronautical Study to be conducted to determine whether the height sought by the applicant and supported by the local state body is admissible or not. The Aeronautical Study shall be conducted only after the applicant submits the letter from the local body justifying the height as sought by the applicant.
